Invite the Child to Take the Camp HOPE America Non-Violence Pledge

Sample Script Adapted from Camp HOPE America - Oklahoma, OKC

Site Coordinator: Camp can be really awesome and if you go to Camp HOPE America, we're going to get to do a lot of fun activities. We want to keep everyone safe, so we have some rules. How do you feel about rules? **(Child Responds)**

Site Coordinator: Well, we don't have a lot of rules, but there is one really big rule that is really important. If this rule isn't followed, there is a really big, negative consequence. Do you want to guess what the rule is? **(Child Responds)**

Site Coordinator: Camp HOPE America's big rule is that we never use our hands or our bodies to hurt other people. Why do you think we might have that rule?

(Child Responds)

Site Coordinator: Repeat after me: "I promise never use my hands or my bodies to hurt other people."

Child Repeats: "I promise never use my hands or my bodies to hurt other people."

Site Coordinator: Everyone at Camp HOPE America has experienced some kind of hurt or violence. We won't know every person's story, but we do know that everyone has been hurt at some point. At Camp HOPE America, we want everyone to feel safe and never have to worry about how they will be treated. If you choose to use your hands to hurt someone else, you will have to leave camp and will miss out on all of the fun. What do you think of that consequence? Does that seem fair to you?

(Child Responds)

Site Coordinator: If you get to go to camp, will you be able to follow this rule? **(Child Responds)**

Site Coordinator: I'm so proud of you! You're making a really good choice—not just for camp, but for life. When two people make a promise or a deal, they shake hands to make it official. Will you shake my hand to seal the deal?
