

FROM OUR PRESIDENT

Dear Friends,

Thank you for supporting the work of Community Against Sexual Harm. 2018 was a big year as we celebrated 10 years of serving women. When we started, we were the only organization exclusively serving women who have been commercially sexually exploited in Sacramento. Eleven years later, we have a lot of partners that help us meet the needs of exploited women, but we remain the only organization in our region with a mission to do this work.

Today, we educate, support, house, heal, and celebrate the victories of women who are changing their lives – and in many cases, the lives of their children. We continue to do this work because we believe that a sense of belonging heals and that peer-mentors, not punishment, help women change the direction of their lives. Over the last year, we have seen lives transform from addiction and street homeless to sober and employed. We've celebrated healthy babies and new homes for women who just needed support to realize their dream of stability. We've seen hope in women when their prostitution charge is dismissed because they chose our educational class and their future. We've also seen relief when we are able to tell a trafficked woman that we can help with everything she needs, immediately.

This annual report will share our 2018 successes and will highlight the work we are excited about in 2019. We believe that building community and standing against sexual harm improves the lives of women and children in our community. We are grateful that we are able to do this critical work.

OUR ACCOMPLISHMENTS

2018 Successes

We served 295 Women.

More than 80% of the women that "drop-in" to our center take advantage of at least one additional program or service.

Supported 32 pregnant women with mentoring, education, and access to quality medical care.

Peer mentors serve as an example of what is possible. For pregnant women, support that understands what you are going through is critical to a healthy, happy pregnancy. We worked in partnership with Dignity Health, Chicks in Crisis, City of Refuge, and ICAN Victim Services to wrap women in support.

Partnered with The CARES Foundation to provide 117 HIV tests.

40% of the women we serve know their HIV status. Our goal is 100%

Diverted 94 women from the criminal justice system through our RESET prostitution diversion program.

For far too long women have been incarcerated instead of helped, which is not a system that can eliminate exploitation. Our program supports, educates, and listens to women.

Assisted 54 women through our comprehensive Opening Doors Anti-Trafficking program.


100% of women who have been in the program for one year or more received both medical and mental health care and support.

2019 Goals

We are focusing on internships and employment, long-term residential stability, social connection, and community building to create a strong system of support that improves the lives of the women we serve. We are also embarking on an ambitious collaborative project to help determine how many people in Sacramento County are sex-trafficked. This important work will help us all understand **the scope of this problem in our community.**
