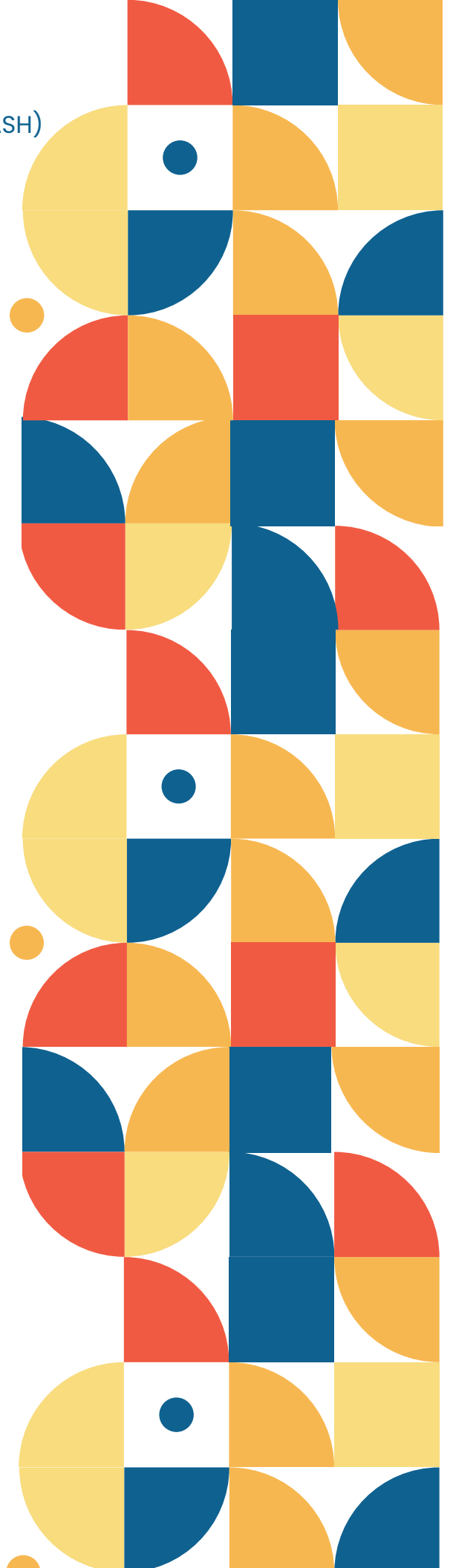

DIGNITY HEALTH MEDICAL SAFE HAVEN AT CASH

The Dignity Health Medical Safe Haven at CASH is a beacon of hope and compassion, dedicated to providing unwavering support to women who have faced exploitation. Since our first official clinic day on April 9, 2024, we have strived to create a safe space where individuals can access medical care and comprehensive support services. 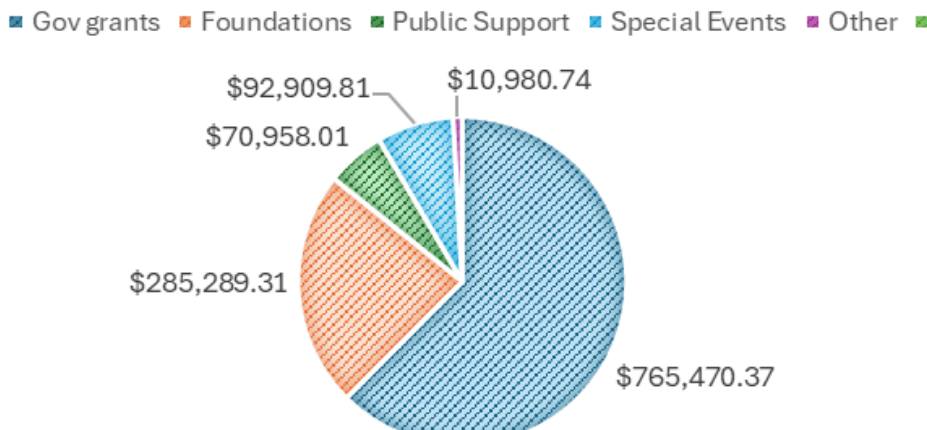

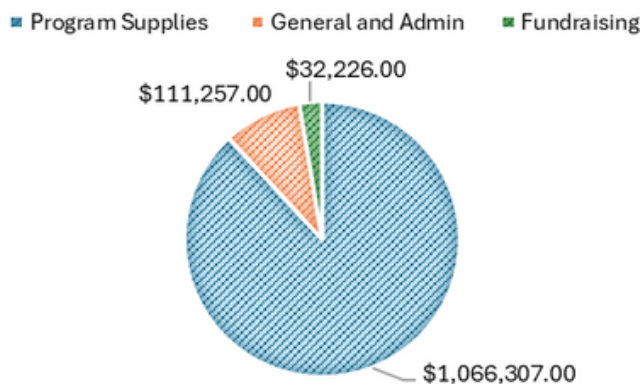
